


Non-fatal Incidents 2014 - 2023


By Year

Incident Type ● Dangerous Occurrence ● Fatality ● Non-fatal injury ● Non-work related




Non-fatal Incidents 2014 - 2023


Fatalities 2014 - 2023






Pre-Employment Questions

Pre-Employment Questions

1. Do you have contractors on site?
2. Do you have a contractor pre-employment Safety & Health questionnaire?
3. Do you have a contractor approval list for your site?

Pre-Employment Questions

7. Do you obtain a list of contractor employee's that will work on site?
8. Do you obtain relevant statutory certification for equipment used by the contractor?
9. Do you check that the equipment is in a safe condition and suitable for use?



Working on site

Working on Site Questions

1. Are contractors inducted on site specific Health & Safety Rules and signed off?
2. Have contractors been made aware of Traffic Management Plans for the site?
3. Have contractors been made aware of Isolation Procedures for the site?



Working on Site Questions

4. Has the manager nominated a person to communicate with contractor's on site daily?
5. Do contractors have to sign in and out of the site on a daily basis?
6. Are contractors visited or inspected on a daily basis on site?



Working on Site Questions


7. Do contractors have an area to organise work and store material and equipment?
8. Do contractors have access to welfare facilities on site?
9. Have contractors been made aware of the emergency plans for the site?
10. Do you check contractors' safety documentation to reflect how work is carried out on site?



Miscellaneous Questions

Miscellaneous

1. Do you have quarry delivery contractors with three or less employed on site?
2. Do you have CoP Risk Assessment and sign off sheet for the delivery contractor?
3. Do you provide artificial lighting to contractors outside day light hours?



Miscellaneous

4. Do you provide adequate edge protection for contractors on quarry benches?
5. Do you allow contractor's employees to drive your quarry mobile plant?
6. If 'Yes' Have you communicated the quarry risk assessments and procedures to the person?


